






2019 Legislator of the Year

1:00 – 4:00 Mind in the Making - 7 Life Skills Every Child Needs

Hosted by Idaho's Mind in the Making Trainer Team: Lisa Burke, Phyllis Vernon, Omair Shamim and Bill Foxcroft

Ellen Galinsky's Mind in the Making presents some of the most important and groundbreaking research about brain development and how learning builds on the structure and function of the brain. These discoveries about how children learn are molded into seven simple but profound skills that predict success in the twenty first century; (1) focus and self-control; (2) perspective taking; (3) communicating; (4) making connections; (5) critical thinking; (6) taking on challenges; and (7) self-directed, engaged learning.

This introductory session will introduce participants to these seven essential life skills. We'll learn why they are important to children and adults, how they develop and how we can promote the use of these Life Skills in children. The trainers will gather feedback from the training in order to decide next steps in providing this information to families and professionals in the early childhood field.

Guest Speakers

Tommy Sheridan is the Deputy Director for the National Head Start Association (NHSA) in Alexandria, VA. He came to NHSA in June 2009. Tommy works with the Head Start community to lobby, advocate, educate, and inform Congress, the White House, and the Federal Administration about Head Start and early learning. Tommy is NHSA's representative to Congress, the Administration, and national coalitions and organizations. He also plays a significant role in developing, strategizing, coordinating and implementing the Head Start community's vision for the future of Head Start and early learning. Prior to his career at NHSA, Tommy worked in the Minnesota State Senate, on several political campaigns, and as a sales manager. Tommy received an Honors Bachelor of Arts from Saint Louis University and a Masters of Public Administration from George Washington University.

Allen Mattison is a lawyer who represents nonprofit organizations on lobbying, campaign finance laws and tax law. He helps nonprofit leaders understand the line between educational and lobbying activities, to help them stretch their non-lobbying funds to get the greatest advocacy impact possible. That way, nonprofits can save scarce lobbying dollars for when they will have the biggest bang for the buck.

Before becoming a lawyer, Allen worked in political communications, serving as the Sierra Club's national media relations director and in communications roles on campaigns and in the U.S. Senate. These experiences give Allen perspective on the challenges nonprofit managers face in developing programs that maximize their advocacy power within the restrictions imposed on section 501(c)(3) organizations.
